### 1. Introduction and purpose

The purpose of this paper is to update and assure the Governing Body on the CCG's readiness for winter based on the recent planning process, including all system partners to ensure that robust delivery and escalation plans are in place.

### 2. Background

In preparing for the delivery of health services over the winter period organisations and systems have been asked to develop their resilience plans based on three integral areas;

- Winter and seasonal pressures
- A second wave of Covid-19
- Restoration and recovery of elective work as described in phase 3 recovery plans



### 3. Approach

NHS North Yorkshire CCG supports three A&E Delivery Boards across the county; York/Scarborough Health and Care Resilience Board, Harrogate and Rural District A&E Delivery Board and Tees Valley ICP Local A&E Delivery Board alongside health and social care system partners from each geographical area.

The CCG has worked with system partners to collectively develop the system seasonal resilience plans for 2020/21 using intelligence gained from review of winter 2019/20 and scenario planning work involving all partners and supported by the Humber Coast and Vale (HCV) ICS Urgent and Emergency Care Network.
