# **PMS Contract and Novation of Contract (Harewood Medical Practice)**

## 1.0 Introduction and Background

The purpose of this paper is to detail the application from Harewood Medical practice to novate the PMS contract to Heartbeat Alliance GP Federation, trading as Hambleton, Richmondshire and Whitby GP Alliance Ltd. (HBA).

**Harewood Medical Practice** is the GP practice with responsibility for the population of Catterick Garrison, one of the largest military centres in the UK. The practice has a long history of providing services to military families and veterans. These services formed part of their original application to become a PMS practice.

The Harewood practice contract is currently held by Leyburn Medical Practice. Leyburn has been working to build a more sustainable primary care service through the economies of scale arising from a larger population. However, given the unique features of the military population, the needs of the Catterick Garrison patient population proved difficult to meet within the contract value. In late 2019, Leyburn Medical Practice indicated that if the value of the contract was increased, they would need to divest themselves of the Harewood contract from December 2019.

**Section 96 funding** was requested from, and approved by, the CCG. The value of this funding is an additional £174k annual recurrent funding which will grow with the patients list and inflation.

With financial stability for Harewood achieved the partners at Leyburn Medical Practice wrote to Heartbeat Alliance in May 2021 to state that:

"...it is in the longer-term interests of both Leyburn Medical Practice and Harewood Medical Practice and the partnership to seek to transfer the Harewood Medical Practice contract to Heartbeat from 31 March 2022. This is on the grounds that now that it has been turned around financially and that the clinical model transformation programme is almost complete Harewood should have its own clear identity and greater autonomy as a practice free from the complications of being run by a partnership based at Leyburn where the population is very different with a different clinical model for delivery. This will also allow Leyburn based partners to focus on the continued development of Leyburn Medical Practice."

#### 2.0 Request from Harewood

The below summarises the request from Harewood:

- Trying to run two practices (Leyburn and Harewood) has become difficult for the partners to manage adequately
- Not only does this create a risk to the quality of service provided, it has also had an impact on the personal health of some of the partners involved which is not sustainable
- Process for the transition to the new clinical operating model, which will meet patients' needs and allow a smooth and almost seamless move into the Integrated Care Campus when it opens, is almost complete
- Current Harewood GP Partners, Dr Stephen Wild and Dr Debbie Ashcroft, will transfer with the Harewood contract as will all staff currently working at the Practice including the new Business Operations Manager (Practice Manager) Emma Crumpler.
- Dr Wild and Dr Ashcroft will resign from Leyburn Medical Practice and become employees
  of Heartbeat.

### 2.1 Contract Change Process

The process, as discussed and agreed with NHSE, is detailed at Table 1.

The following should be noted:

- This contract change will ensure the continuity of the practice and will provide assurance of a resilient, long-term assurance going forward.
- NHSE has confirmed that this contract change route has been undertaken elsewhere.
- Harewood Practice have discussed the contract change with the practice staff, so they are aware of the proposal. If the application is approved by the CCG, they will commence the TUPE process and any required staff consultation. There is no requirement for patient or public consultation as services will not affected but patients will be informed of the change.

Step	Notes
The current partners at Harewood will be joined by a new partner, or partners, a GP employed by, or with a shareholding interest in, Heartbeat Alliance on the PMS contract, by contract variation (CV).	This step does not need to be approved by the CCG
The existing Harewood partners will then resign from the contract, which will require a further CV	The recommendation is that more than 1 GP from Heartbeat Alliance will join the Harewood contract initially, thus mitigating the circumstance of leaving the contract "single handed" at any time – this has been agreed with HBA
The remaining GP, or GPs, will then apply	This requires CCG approval
to novate the Harewood contract to Hambleton, Richmondshire and Whitby GP Alliance Ltd which, as a Ltd company, will be able to hold a PMS contract by virtue of its shareholders.	This approval can be justified by the affiliation of the newly appointed GP partner(s) remaining as shareholders within Heartbeat Alliance, and the continuity of service by the former partners becoming salaried members of that organisation.

#### 3.0 Governance and Next Steps

HBA and Harewood Medical Practice have asked that the CCG consider the application prior end December 2021 to allow time for staff consultation and TUPE in readiness for 31 March 2021.

If approved by the PCCC, NHSE will put in place the necessary contracting changes so that the change will take place on 1 April 2022. Following on from this, next steps will include:

- Contract Variations (CVs) will add the new partner(s) to the PMS contract followed by the respective resignations and removal from the contract of the current partners
- NHSE will support the CCG with the formal contracting agreements.

#### 4.0 Recommendation

The Primary Care Commissioning Committee is asked to:

- Note the recommendation from the Executive Directors Group to support the application for the change of contract.
- Approve the application for the change of contract.
