### *Latest concept design...*

We continue to involve local and clinical representatives in the design and service proposals and have recently received formal planning approval. The designs will need to be finalised and subject to formal NHS and MOD approvals, preparations for the build can begin. *Read the latest in this issue.*

## Background

Since 2015, the NHS and MOD have been working together on plans to enhance the range of health and care services for Catterick Garrison and the wider Richmondshire area to help address:

- capacity to support growing numbers of military personnel, dependants and families, as well as the residential population
- limited service integration and communication
- mental health and children's service provision
- access to services
- quality of estates
- rurality and travel

The new facility aims to give all residents of Richmondshire access to the right care, at the right time, in the right setting, delivered by the right professionals to enhance their wellbeing and independence, and improve their overall quality of life.

## Latest news

Formal planning approval has been granted by Richmondshire District Council at a committee meeting 4 October 2022.

Wendy Balmain, North Yorkshire Place Director for the NHS Humber and North Yorkshire Integrated Care Board (HNYICB), said: "The NHS and MOD have been working together since 2015 worked to turn the vision for an integrated health and care campus for military and local civilian populations into reality.

"The formal planning approval is a major milestone, moving us forward with finalising our service proposals and achieving final approvals.

"I would like to thank all our partners for this significant collective achievement that in time will support the needs of the local community."

Air Commodore Luke Houghton said: "We are absolutely delighted to be informed of Richmondshire District Council's formal planning approval of the Catterick Integrated Care Campus design.

"This decision paves the way for an exciting future healthcare facility and delivery model for both the NHS and MOD. It is an opportunity to collaborate and work together and to focus on the health needs of the whole population in the area through excellence in joint clinical practice and learning."

Appointed contractor, Tilbury Douglas says it aim is to maximise social value for the area, with a focus on new job creation and training opportunities for the local community. There are also plans to hold future engagement events together with partners for the local community, which will be advertised locally.

Works have already commenced on site to prepare the site for the start of construction in Spring 2023, subject to approvals.



Several previously unused and dilapidated buildings have now been demolished due to being no longer viable for use.

Baden Powell House, a building with significant history for the local community and MOD will be retained on the site, and following completion of the new health campus, will be refurbished, and remain in use.

Elected representatives across Richmondshire said the campus would bring healthcare provision closer for many residents of the vast and largely district as well as increasing access to NHS services near to some of North Yorkshire's most deprived communities.

Karina Dare, Regional Partnership Director for North East and Yorkshire at NHS Property Services, said: "Passing this important planning milestone is a fantastic achievement and I want to congratulate the clinical teams as well as the technical team for their time and commitment to reach this stage. We will continue to support our NHS colleagues as we move into the next approvals stage with the ultimate aim of supporting delivery of vital services to the local community."

## Progress with the programme

- ✓ Internal and external design concepts shared for comment at events in May, July and November 2022.
- ✓ Funding agreed by NHS and MOD to start enabling works and move towards final approvals.
- ✓ Planning approval formally received from local authority.
- ✓ Site preparation works underway including demolition of unused buildings or that are unsafe.
- ✓ Moving through a schedule of local engagement on the design and services proposed.

## What's next?

- Full Business Case expected 2023
- Sign-off designs early 2023
- Start on site building late 2023
- Projected building completion due 2025

All are subject to change and formal approvals.

## Services being considered

The CICC aims to bring primary care (GP) services under the same roof as MOD, community services, mental health, physical rehabilitation, military and community NHS community dentistry, occupational health, veterans', voluntary and social services. Clinical modelling is currently underway but some of the services being considered are:

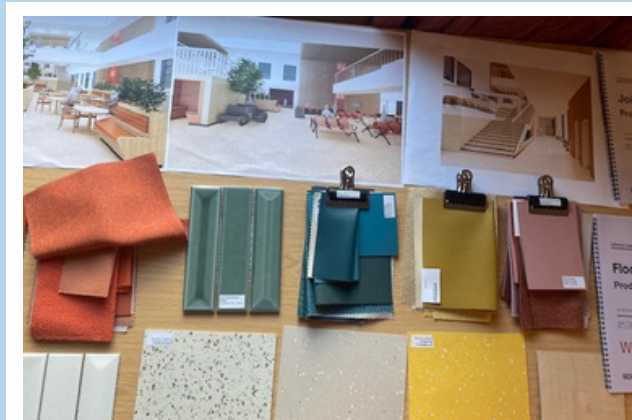

## Latest from contractor, Tilbury Douglas

Tilbury Douglas has been on site since May 2022 undertaking enabling works in preparation for the new CICC. This has included; stripping out and demolition of existing buildings, undertaking various surveys on site, safely rehoming some bats that were residing in some of the buildings, and putting up the hoardings around the site. Current works we are undertaking include crushing the bricks and debris from the demolition and some tree felling, which will be complete by the end of 2022.

## Latest from design partner, BDP

BDP was appointed as part of the Tilbury Douglas team to deliver the detailed design phase of the construction and to bring the project to the planning application. The complex planning application required careful consideration of a number of elements to address all statutory and stakeholder requirements. BDP worked closely with the planning team to ensure that the approval process went smoothly and planning approval was achieved.

BDP is providing architectural, landscape, interior design and planning services, working in collaboration with WSP and Hoare Lea engineering consultants.
